- Discuss the field observation in the Joint Annual Review

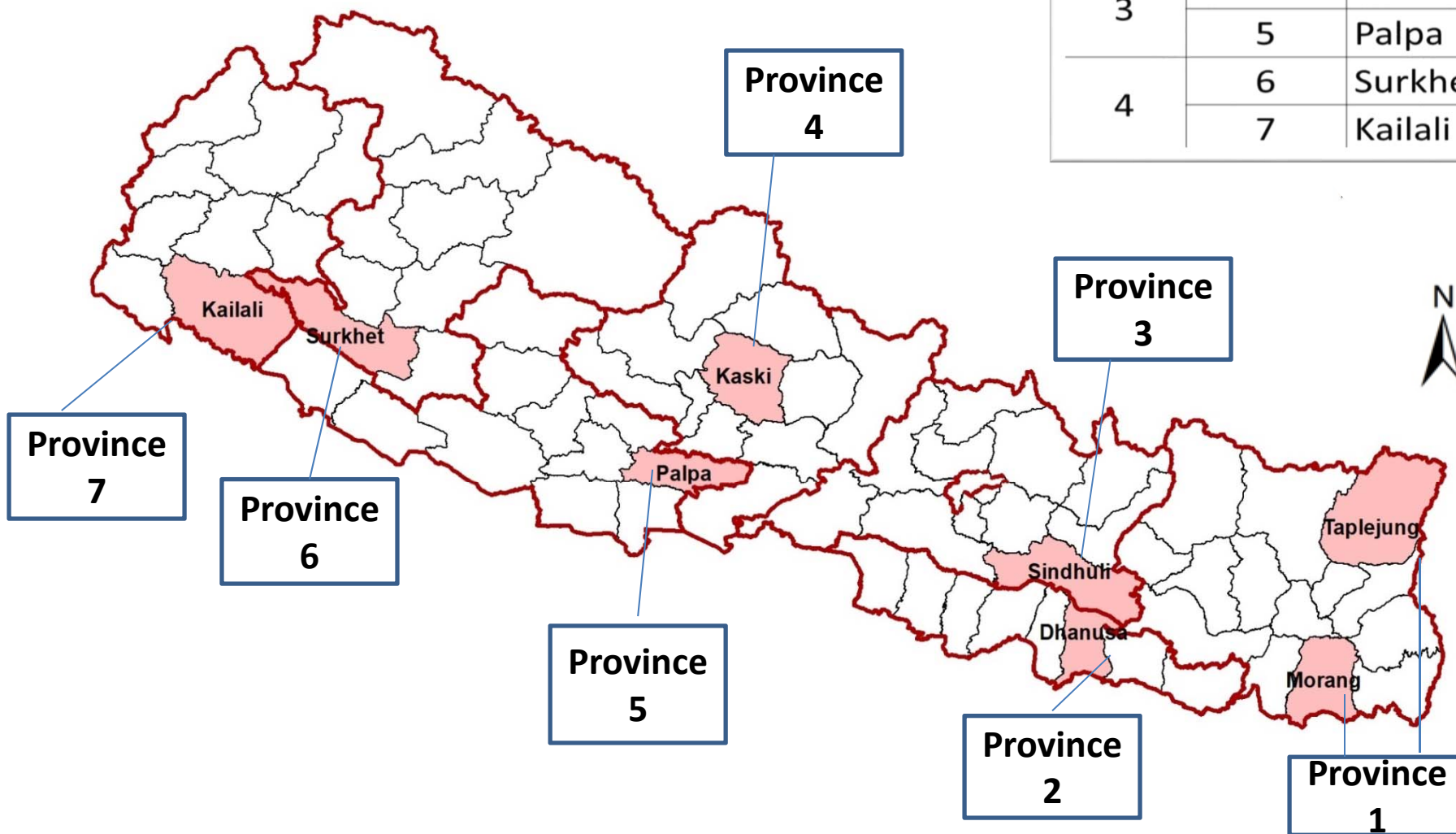
Thematic areas for Pre-JAR field visit
